By enrolling or participating in our services, you agree to the following terms and conditions.

2. Inclusivity and Safeguarding

We are committed to creating a safe, respectful, and inclusive environment for all. We welcome individuals of all abilities, backgrounds, and identities. All staff and volunteers are trained in safeguarding and best practices regarding inclusivity for all users.

Participants and carers are expected to respect others and help foster a welcoming and safe community.

3. Bookings and Payments

- For activity that requires payment, sessions must be booked in advance via our website, email, or approved booking system.
- Payment is due at the time of booking unless otherwise agreed.

4. Refund Policy

We understand that plans may change. Our refund policy is as follows:

- Cancellations by you (the participant or guardian):
 - If cancelled more than 7 days before the session, a full refund or credit will be offered.
 - o If cancelled **less than 7 days before the session**, no refund will be given unless there are exceptional circumstances.
 - In cases of **medical emergencies** or significant unforeseen issues, please contact us as soon as possible—we aim to be understanding and flexible.

• Cancellations by us:

o If a session is cancelled by us for any reason (e.g., illness, venue issues), a full refund or credit will be issued.

5. Lateness Policy

- Please arrive on time to ensure a smooth and engaging experience for everyone.
- Participants arriving more than **15 minutes late** may not be admitted, particularly if the session has safety elements or is performance-based.
- Consistent lateness may affect participation in certain activities, such as performances or showcases.

We understand that lateness can sometimes be linked to SEND-related challenges. If this applies, please contact us so we can make reasonable accommodations.

6. Right to Change Teachers or Workshops

We reserve the right to:

- Change or substitute **teachers**, **facilitators**, **or volunteers** when necessary due to illness, scheduling conflicts, or organisational needs.
- Alter or adapt **workshop formats, content, or locations** if required for safety, access, or curriculum improvements.

All changes will be communicated in advance where possible, and we will strive to maintain the quality, continuity, and inclusivity of our sessions.
